POLICIES

All custom wheel orders require payment in full at time of order (unless specific arrangements have been approved by Canyon Motorcycles Online LLC) and no returns of custom ordered products are accepted.

RETURN POLICY

We must receive your unused, uninstalled, and unopened item(s) within 15 days from the date of delivery. All original packaging must be included. You will be required to pay the shipping to and from Canyon Motorcycles. An 18% restocking fee will be applied to all returns (exceptions apply). The item(s) MUST be new in original packaging and uninstalled. To receive a refund the item(s) MUST be in resalable condition. If the item is not in resalable condition it will be refused. You are welcome to exchange an item(s) for reasons of personal preference; however, return policies will apply to all exchanges. Any returns requested after 15 days will not be eligible for a refund, store credit will be issued. Item(s) cannot be returned or exchanged after 30 days. Authorization is required for all returns. You will be emailed a RMA number if the return has been approved by the returns department. The RMA number will need to be written on the outside of the box. Items sent without a RMA number or/and without original packaging could result in your package being refused or subject to an additional \$15.00 administrative fee. An RMA number is ONLY valid for 7 days. RMA's older than 14 days will be refused.

DAMAGED SHIPMENTS

If the package was damaged during shipment we will need the following to process the claim:

1. Picture of the damaged box
2. Pictures of the items that were damaged in transit
3. Email info@canyonmotorcycles.com with the circumstances and summary of the damage.

ALL DAMAGE CLAIMS MUST BE REPORTED WITHIN 5 DAYS OF RECEIVING THE PRODUCT.
